Scenario: A traveler, while TDY at Location A, was required to perform an additional TDY overnight in Location B. The AO agreed that it would be more economical for the traveler to retain the Location A lodging arrangements while TDY in Location B and authorized or approved Location A's lodging cost as a reimbursable expense. The Location B lodging cost (\$120 a day) was used for computing the traveler's per diem while at that TDY location.
