Scenario: A civilian employee travels on a PCS move, leaving the old PDS in Ramstein, Germany and traveling to the new PDS in Warsaw, Poland. The civilian employee elects to travel by privately owned vehicle (POV), accompanied by a spouse and 12-year-old child. The official distance between the two authorized points is 753 miles. They depart their residence at 7 a.m. on May 26 and arrive in Warsaw at 6 p.m. on May 28, occupying 2 nights of lodging. For the first night of lodging in Leipzig, Germany, where the per diem rate is \$197 for lodging and \$113 for meals and incidental expenses (M&IE), the civilian employee only used \$160 for lodging. For the second night of lodging in Poznan, Poland, where the per diem rate is \$126 for lodging and \$88 for M&IE, the employee used the full \$126 for lodging. According to the JTR, the Lodging Plus method is used, so although the civilian employee is authorized up to \$807.50, the employee's reimbursement must be limited to the actual lodging costs of \$286. The per diem rate at the new PDS is \$92 for M&IE.
